To be eligible for a Register of Merit Excellent (ROMX) Award, the subject dog is to have been: the Sire of twenty-five (25) or more, or the Dam of ten (10) or more, Champions of Record. The progeny are to be Champions of Record, confirmed by AKC.

How to apply for your award:

To apply for your ROM/ROMX please submit the one of each item below:

- 1. An AKC Progeny Report for the sire or dam listing the Champions of record available from the AKC On-Line Store for \$25.00; OR listing of all progeny of said sire/dam indicating published dates championship in the AKC Gazette; OR include a check payable to BFCA for \$25.00 in order to obtain an AKC On-Line Progeny Report. If BFCA obtains the progeny report a copy will be mailed to you.
- 2. Copy of current AKC registration, showing all owners of the sire or dam

Finally, Kathy Loynachan our Show Chairman has offered to have folks send items to her if needed, Kathy will be driving to the National.


